## SHUDDUP N' DANCE 2017 CITTA Mall Selection RULES & REGULATIONS

*Shuddup N' Dance 2017 is a street dance competition organised by CITTA Mall (8 – 9 July 2017).*

*This registration form and Rules & Regulations are strictly to be used only for **CITTA Mall's** selection round.*

1. Shuddup N' Dance 2017 CITTA Mall Selection ("Event") is organised by Attic Holdings Sdn Bhd. ("Organiser").
2. The Event will be held at the mall's Drop-off point on the Ground Floor ("Venue").
3. The Event is open to anyone without limits to age or nationality.
4. The Event will feature TWO (2) categories: **SOLO** and **GROUP**, where winners of both categories will proceed to the Grand Finals held in Klang Parade on 20 August 2017. Additionally, there will be another stand-alone sub-category, the **K-Pop Dance Cover Competition**.

6. The Event Rules and Regulations for the Street Dance categories (SOLO and GROUP) are as follows:
  - a. The competition will be based on a **Freestyle Street Dance format** where we accept acts like Breaking, Popping, Locking, Krumping, Waacking and/or other forms of dance including Traditional, Latin, Contemporary, Line Dancing, etc. Participants are allowed to incorporate different dance genres into their performance, so participants are encouraged to be creative with their routines.
  - b. Street Dance Categories:
    - i. **CATEGORY 1: SOLO FREESTYLE 1-ON-1 BATTLE**
      1. Participants must be present for Auditions on 9 July 2017 by 11:00am to register and to attend the briefing. Competition starts sharp at 12:00 noon
      2. In Round 1, participants will be grouped randomly (based on drawn lots) and each participant will perform a freestyle routine matching the music spun by the DJ.
      3. Each performance should last no longer than ONE (1) minute.
      4. Selected participants will proceed to Round 2 (Top 16) where each participant will be given ONE (1) minute to "battle" and showcase their dance moves against their opponents.
      5. Judges will determine winners of the battle rounds on the spot.
      6. Participants who make it to The Top 4 of this category will proceed to the Shuddup N' Dance Grand Finals happening in August 2017 at Klang Parade.
      7. Selection is based on the following criteria: Technicality, Creativity, Originality, Attire, and Overall Performance.
    - ii. **CATEGORY 2: FREESTYLE OPEN CREW SHOWCASE**
      1. Participants must be present on 9 July 2017 by 2:00pm to register and to attend the briefing. Competition starts sharp at 4:00pm
      2. Participating groups must consist of a minimum of TWO (2) members; there is no maximum limit for the number of members.
      3. Each performance should not exceed FIVE (5) minutes.
      4. Music used **MUST NOT** contain profanities; religious, racial or political sentiments; or any element that may cause disharmony or evoke feelings of unpleasantness. Failure to comply shall result in automatic disqualification.
      5. Participants who make it to The Top 3 of this category will proceed to the Shuddup N' Dance Grand Finals happening in August 2017 at Klang Parade.
      6. Selection is based on the following criteria: Technicality, Creativity, Originality, Attire, and Overall Performance.
- c. **Sub-Category: K-Pop Dance Cover Competition (Auditions 8 Jly Finals 9 July)**
  - i. Participants must be present on 8 July 2017 at 1:00pm for briefing and registration. Auditions start at 2:00pm sharp. Maximum of 10 teams will proceed to the Finals on 9 July 2017 at 2:00pm.
  - ii. Registration is open to all age groups regardless of nationality.
  - iii. Each group must contain a minimum of TWO (2) members; there is no maximum limit for the number of members.
  - iv. Each person can join only ONE (1) crew!
  - v. Participating groups are required to prepare a K-Pop dance routine for the judges (5 minutes max), with songs or medleys from only **ONE (1)** K-Pop Group, i.e. mash-ups or medleys of many artists are not permitted for this category.

- d. Props are allowed for the **GROUP** category only. All groups with props must obtain prior approval from the Organiser.
  - e. Attire may include accessories such as hats, caps, gloves, scarves, etc.
  - f. Removing pieces of clothing during the performance is permitted as long as it is not offensive, inappropriate, or out-of-character.
  - g. Appropriate undergarment **MUST** be worn by all participants, both male and female, at all times.
  - h. Clothing too short and/or too tight will be scrutinised and may be deemed inappropriate, especially overexposure of certain areas of the body considering the family friendly nature of the competition.
  - i. Body oils or other substances applied to the body or clothing that may affect the clean, dry surface of the staging area and the safety of fellow participants are prohibited.
  - j. Judges' decisions are final at all stages of judging and no correspondences on scoring will be entertained.
7. The prizes shall be as follows:
- a. SOLO Champion – **RM1,000** worth of cash & prizes
  - b. SOLO 1st – 3rd Runners-Up – **RM250** worth of prizes each
  - c. OPEN GROUP Champion – **RM2,000** worth of cash & prizes
  - d. OPEN GROUP 1st Runner-Up – **RM1,000** worth of cash & prizes
  - e. OPEN GROUP 2nd Runner-Up – **RM500** worth of cash & prizes
  - f. K-POP Dance Cover Champion – **RM1,000** worth of cash & prizes
  - g. K-POP Dance Cover 1st Runner-Up – **RM500** worth of cash & prizes
  - h. K-POP Dance Cover 2nd Runner-Up – **RM300** worth cash & prizes
- Prizes for the K-Pop Dance Cover segment will be presented on the day of the competition OR at a date no later than 30 days from the date of the competition (due to sponsored products). Prizes for the SOLO and GROUP categories will only be presented at the Grand Finals in August with the other finalists. Those who cannot make it due to any unforeseen circumstances will forfeit their prizes.*
8. By participating in the Event, all participants agree and acknowledge that:
- a. Participants are in good state of health to take part in the Event;
  - b. It is the responsibility of participants to report of a group member's injury or illness to the Organiser or Judges prior to the event;
  - c. If at any time prior to or during the Event a participant is ill, injured, or is jeopardising their physical and emotional condition by participating in the Event, he/she may be declared ineligible to compete, or disqualified from competing any further;
  - d. The Organiser reserves the right to withdraw any participant who appears to have a serious disability, injury, or requires medical attention;
  - e. Participants below the age of 18 must have their parents' or legal guardians' consent to take part in the Event;
  - f. All relevant permissions from any institutions have already been obtained (if any);
  - g. None of the participants are legally bound by contract to any talent agencies, sponsors or organisations;
  - h. All photos and videos captured by the Organiser and its agencies can be used for any form of promotional content without prior consent;
  - i. The Organiser reserves the right to amend the Rules and Regulations of the Event at its absolute discretion without prior notice and no correspondence will be entertained.
9. With regards to scoring, protests are prohibited and will not be accepted. All Judges have acquired the necessary skills, experience, and training in their respective fields to be qualified for judging.
10. In the highly unlikely event of any accident throughout the Event, the Organiser and all its agencies related will not be held liable.
11. By participating in the Event, participants hereby grant permission for the Organiser to share their contact information with its partners and sponsors for any commercial or non-commercial related purposes.
12. The Organiser reserves the rights to alter any parts of the Rules and Regulations of the Event, and to replace the prizes with items of similar value without prior notice.
