



SHUDDUP N' DANCE 2016 1 Mont Kiara Selection RULES & REGULATIONS

Shuddup N' Dance 2016 is a dance competition jointly organised by Ipoh Parade (19-20 March 2016), 1 Mont Kiara (22 May 2016), CITTA Mall (23 July 2016) and Klang Parade (13-14 August 2016), with the Grand Finals scheduled to take place at Klang Parade on 20 August 2016.

1. Shuddup N' Dance 2016 1 Mont Kiara Selection ("Event") is organised by 1MK Retail Sdn. Bhd. ("Organiser").
2. The Event will be held at 1 Mont Kiara's Atrium, Ground Floor ("Venue").
3. The Event is opened to anyone without limits to age or nationality.
4. The Event will feature TWO (2) categories: SOLO and GROUP.
5. The Event's Rules and Regulations are as follows:
 - a. The competition will be based on an **Open Dance format** where we accept acts like Breaking, Popping, Locking, Krumping, Animation and other forms of dance including Traditional, Latin, Sync Dancing, Line Dancing, etc. Participants are allowed to incorporate different dance genres into their performance, so participants are encouraged to be creative with their routines.
 - b. To enter the competition, participants will need to download the registration form available under the Event tab at 1 Mont Kiara's Facebook page (www.facebook.com/1MontKiara), OR obtain the forms available at the Information Counter on the Ground Floor. Completed forms must be submitted to the mall's Management Office in person or via email to contact@eventplusmarketing.com latest by 18 May 2016, 5:00pm.
 - c. Categories of the Event are as follows:
 - i. SOLO
 1. Participants must be present for the Auditions on 22 May 2016 at 11:00am to register and to attend the briefing.
 2. In Round 1, participants will be grouped randomly (based on drawn lots) whereby each participant will perform a freestyle routine matching the music spun by the DJ.
 3. Each performance should last no longer than ONE (1) minute.
 4. Selected participants will proceed to Round 2, where each participant will be given ONE (1) minute to "battle" and showcase their dance moves against their opponents in the Top 32 rounds. The battle format continues until the champion is determined.
 5. Judges will determine winners of the battle rounds on the spot for all battle rounds.
 - ii. GROUP
 1. Participants must be present on 22 May 2016 by 2:00pm to register and to attend the briefing.
 2. Participating groups must consist of a minimum of TWO (2) members and not exceed EIGHT (8) members.
 3. Each performance should not exceed FIVE (5) minutes.
 4. Music used **MUST NOT** contain profanities; religious, racial or political sentiments; or any element that may cause disharmony or evoke feelings of unpleasantness. Failure to comply shall result in automatic disqualification.
 - d. Selection is based on the following criteria:
 - i. Technicality
 - ii. Creativity
 - iii. Originality
 - iv. Attire
 - v. Overall Performance
 - e. Props are allowed for the GROUP category but prior approval must be obtained from the Organiser.
 - f. Attire may include accessories such as hats, caps, gloves, scarves, etc.
 - g. Removing pieces of clothing during the performance is permitted as long as it is not offensive, inappropriate, or out-of-character.
 - h. Appropriate undergarment **MUST** be worn by all participants, both male and female, at all times.
 - i. Clothing too short and/or too tight will be scrutinised and may be deemed inappropriate, especially overexposure of certain areas of the body considering the family friendly nature of the competition.

- j. Body oils or other substances applied to the body or clothing that may affect the clean, dry surface of the staging area and the safety of fellow participants are prohibited.
 - k. Judges' decisions are final at all stages of judging and no correspondence will be entertained.
6. The prizes shall be as follows:
- a. SOLO Champion – RM1,000 cash & prizes
 - b. SOLO 1st – 3rd Runners-Up – RM100 prizes each
 - c. GROUP Champion – RM4,000 cash & prizes
 - d. GROUP 1st Runner-Up – RM2,000 cash & prizes
 - e. GROUP 2nd Runner-Up – RM1,000 cash & prizes
- Winners shall receive their prizes within 30 days after completion of the Event. Uncollected prizes within 60 days from announcement of winners will be considered null and void.*
7. The Event will crown Top 4 SOLO Freestyle Battle Winners and Top 3 Dance Crews under the GROUP Showcase category. They will represent 1 Mont Kiara at the Grand Finals of Shuddup N' Dance 2016 in Klang Parade, 20 August 2016.
8. By participating in the Event, all participants agree and acknowledge that:
- a. Participants are in good state of health to take part in the Event;
 - b. It is the responsibility of participants to report of a group member's injury or illness to the Organiser or Judges prior to the event;
 - c. If at any time prior to or during the Event a participant is found ill, injured, or is jeopardising their physical and emotional condition by participating in the Event, he/she may be declared ineligible to compete, or disqualified from competing any further;
 - d. The Organiser reserves the right to withdraw any participant who appears to have a serious disability, injury, or requires medical attention;
 - e. Participants below the age of 18 must have their parents' or legal guardians' consent to take part in the Event;
 - f. All relevant permissions from any institutions have already been obtained (if any);
 - g. None of the participants are legally bound by contract to any talent agencies, sponsors or organisations;
 - h. All photos and videos captured by the Organiser and its agencies can be used for any form of promotional content without prior consent;
 - i. The Organiser reserves the right to amend the Terms and Conditions of the Event at its absolute discretion without prior notice and no correspondence will be entertained.
9. With regards to scoring, protests are prohibited and will not be accepted. All Judges have acquired the necessary skills, experience, and training in their respective fields to be qualified for judging.
10. In the highly unlikely event of an accident throughout the Event, the Organiser and all its agencies related will not be held liable.
11. By participating in the Event, participants hereby grant permission for the Organiser to share their contact information with its partners and sponsors for any commercial or non-commercial related purposes.
12. The Organiser reserves the rights to alter any parts of the Rules and Regulations of the Event, and to replace the prizes with items of similar value without prior notice.
